In this interpretation NHTSA was responding to Calcoast-ITL on whether the reflex reflector function can be moved from a fender mounted rear lamp assembly to the decklid mounted lamp. NHTSA ruled no. The second interpretation was a request from Calcoast-ITL to clarify if aftermarket manufacturer of replacement lamps can use different bulbs and sockets than the original equipment. 7/31/03	44892	Final Rule- New School Bus Category NHTSA established a new class of school buses to be used for school activity such as fieldtrips - multifunction school activity bus (MFSAB). Lotus argues that the current headlamps do not pose a safety issue because the headlamp's photometrics are very close to the requirements. See docket #16341
